

## Alcohol & Drug Policy

## Crime Tips & Whistle Blower

In an effort to reduce crime and criminal activity on campus, the Department of Public Safety has created a Crime Tip web-page specifically designed to allow students, faculty, staff and friends the opportunity to anonymously report officer conduct, whistle blower information, crimes and criminal activity on campus. The site can be accessed by logging onto the CAU website home page. After accessing the home page, go to Departments, drop down and click on the Public Safety tab, then drop down to Crime Tips and the page will display. Please be mindful of the fact that this page is not intended for emergency reporting, only submit silent witness information and crime tips.

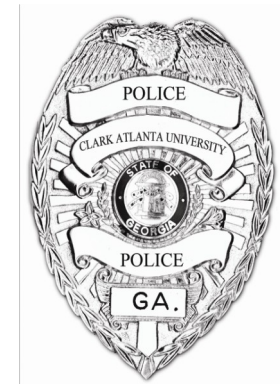

## Crime Prevention Information

- Respectfully decline having your photo taken by strangers.
- Avoid dissemination of your personal information.
- Be aware of date rape drugs and avoid situations which expose you to potential threat of victimization.
- Avoid "PROPPING" the doors to residential, recreational and academic facilities open.
