Enrollment is a key performance indicator for Clark Atlanta University (CAU) Strategic Plan Goal 1: Enrollment and Student Success. As a performance metric, CAU tracks the undergraduate and graduate student enrollment.

Objective 1: Increase Undergraduate and Graduate student enrollment by 2023. Goal: Fall Enrollment headcount is 4,110-4,230 (75% Undergraduate/25% Graduate composition).
