Enrollment is a key performance indicator for Clark Atlanta University (CAU) Strategic Plan Goal 1: Enrollment and Student Success. As a performance metric, CAU tracks the undergraduate and graduate student enrollment.

Objective 1: Increase Undergraduate and Graduate student enrollment by 2023.

Goal: Fall Enrollment headcount is 4,110-4,230 (75% Undergraduate/ 25% Graduate composition).

Note: FTE methodology has been updated to be aligned with the majority of the University's external reporting requirements.

Prior Year Reporting (Fall 2021)

FTE for Undergraduate Enrollment: Number of FT UG Headcount plus Total PT UG credit hours converted to FT divide Total PT hrs. by 12)

FTE for Graduate Enrollment: Number of FT Grad Headcount plus Total PT Grad credit hours converted to FT (divide Total PT hrs. by 9)

Current Year Reporting (Fall 2022 – Fall 2023)

Full-Time Equivalent (FTE) for Total Enrollment = Number of full-time students + one-third of the part-time students. FTE for Undergraduate Enrollment = Number of full-time Undergraduate Students + one-third of the part-time Undergraduate students.

FTE for Graduate Enrollment = Number of full-time Graduate Students + one-third of the part-time Graduate students.

***University Housing counts were not included in the Fall 2021 Official Enrollment Census Report. Fall 2023 University housing includes both on and off-campus housing.
