

Educational Leadership Tier II - Educational Specialist (Ed.S.) and Doctorate of Education (Ed.D.)

The Ed.S. and Ed.D. programs in Educational Leadership offered by Clark Atlanta University are designed to meet Georgia requirements for Educational Leadership certification (Tier II), but may not be recognized by other states.

The table below indicates, for each state, whether CAU's Ed.S. and Ed.D. programs in Educational Leadership meet or do not meet the educational requirements for a Leadership certificate or whether CAU has been unable to determine if the programs meet the state requirements). Each state board, agency and or department has the ultimate authority and discretion to determine whether professional licensure or certification will be issued, and students are strongly encouraged to contact the regulatory agencies where they would like to teach.
