**Gregory B. Morrison (2004) Chair  
Atlanta, Georgia,**

Gregory B. Morrison served as Corporate Chief Information Officer for Cox Enterprises, a communications, media, and automotive services company from February 2002 until his retirement in January 2020. There, he was responsible for providing corporate strategic planning and policy development, leveraging deployment of new information technology across the company's operations. Previously, Mr. Morrison spent 12 years with Prudential Financial, serving in a variety of Information Technology and Systems leadership and CIO roles. Mr. Morrison brings to the board of trustees extensive knowledge and expertise with large-scale business transformations and technology deployments. He also serves as director of Rollins, Inc., Veritex Holdings, Inc., Amerisure Mutual Insurance Company, and IEWC Corporation. In addition, he serves as Chairman of the Clark Atlanta University board of trustees. Leonard Walker brings previous banking and venture capital exposure to the Board of Trustees. As Business Banking Division Manager for Wells Fargo Bank (formerly Wachovia Bank, N.A.), he headed banking activities for more than 4,000 companies with annual sales ranging from \$3M to more than \$25M and maintaining responsibility for all corporate banking, treasury services, credit and capital management needs for Business Banking Customers in Atlanta. As founder and principal of Cyber-Starts, an institution-backed venture capital firm based in Atlanta and funded, in part, by Wachovia, Walker created, acquired, and managed companies focusing on the intersection of financial services and technology. Walker's banking career includes 11 years with JPMorgan Chase in New York,

New York, where he held a number of senior management positions, including Small Business Financial Services and Division Executive in Middle Market Banking. ### **Stephanie Russell (2013) (MBA 1993) Secretary Atlanta, GA**

Guided by a commitment to service as community activist and volunteer, Mrs. Russell has focused her attention and energies in the areas of health and education as they impact the well-being of children and women, particularly African-American. Professionally, Mrs. Russell served internships with the Coca-Cola Company and McMaster-Carr Industry Supply Company, after which she held positions as brand Manager, Fountain Division, the Coca-Cola Company; Product Development Manager, Bell South Cellular, where she was responsible for creating brand relevancy and advertising plans for the GT Wireless program. Mrs. Russell actively supports several organizations and initiatives. Following a successful transplant between her husband and his brother and garnering in excess of \$300,000, she organized and sponsored the first-ever African American Kidney Fund Gala

to advance awareness and promote the Fund. In addition, the Fund was beneficiary of a \$100,000 family gift. Mrs. Russell serves as member of several philanthropic and community organizations including: Board of the National Black Arts Foundation, Wren's Nest; Villages of Carver YMCA; and the Westminster Schools "Wilbur and Hilda Glenn Institute for Philanthropy and to Serve Learning. She is actively involved on committees within the Woodward Academy community and the Girl Scouts of America. Mrs. Russell has chaired and cochaired many events throughout the Atlanta Community, including the National Black Arts Festival (NBAF). As a founding member of Granting Atlanta's Wishes (G.A.W.), a nine-woman organization, Mrs. Russell provides assistance to those seeking to pursue educational, entrepreneurial and artistic dreams. She received the Bachelor of Science degree in Industrial Management from the Georgia Institute of Technology and the Master of Business Administration (MBA) from Clark Atlanta University in 1998. Mrs. Russell is married to H. Jerome Russell and they have four children.



### **John Hope Bryant (2022) Atlanta, Georgia**

John Hope Bryant is the first Clark Atlanta University School of Business Entrepreneur Scholar in Residence. Referred to as the Conscience of Capitalism by the CEOs of Delta Air Lines and Walmart, Bryant is an American entrepreneur, author, thought leader, and philanthropic leader. He is the Founder, Chairman, and Chief Executive Officer of Operation HOPE, Inc., the largest not-for-profit and best-in-class provider of financial literacy, financial inclusion and economic empowerment tools and services in the United States for youth and adults. He is also chairman and chief executive officer of John Hope Bryant Holdings, Bryant Group Ventures, and The Promise Homes Company, the largest for-profit minority-controlled owner of institutional-quality, single-family residential rental homes in the United States. In December of 2021, Bryant successfully recapitalized into a

new Promise Homes Co. joint venture for more than \$120 million, paying off all debts and investors. Simultaneously, in December 2021, Bryant successfully closed a 200M credit facility to grow the new housing joint venture, marking one of the largest capital raises by a Black-owned company in more than a decade (according to Black Enterprise). Bryant has received hundreds of awards and citations for his work, including Oprah Winfrey's Use Your Life Award, and the John Sherman Award for Excellence in Financial Education from the U.S. Department of Treasury. Five former U.S. presidents have recognized his work, and he has served as an advisor to three sitting U.S. presidents from both political parties. John Hope Bryant has been recognized by The Atlanta Business Chronicle's "2022 Power 100"; he is named #2 among 100 inspirational leaders on the "Yahoo Finance Empower Role Model list 2022"; he was awarded the 100 Black Men of America "Chairman's Award for Economic Empowerment," Georgia Trend's "100 Most Influential Georgians" in 2022 and 2023, Atlanta Business Chronicle's "Most Admired CEOs of 2018," Atlanta Business Chronicle's "The Power 100: Most Influential Atlantans in 2020," American Banker magazine's 2016 "Innovator of the Year," and one of Time magazine's "50 Leaders for the Future" in 1994. On May 2, 2023, Operation HOPE and Shopify were announced as winners of Fast Company's World Changing Ideas Awards for their partnership to create 1 Million Black Businesses by 2030. John Hope Bryant has also received an honorable mention in Inc. magazine's "The World's 10 Top CEOs" article that spotlights global servant leaders as the visionaries behind some of the most successful organizations.



**Valeisha Butterfield**  
**(2004) Atlanta, Georgia**

Valeisha Butterfield is a globally recognized, award-winning business leader at the forefront of tech, entertainment and politics. She is heralded by millions as a cultural vanguard and women's empowerment leader with a proven track record of uplifting the next generation of creators, entrepreneurs and executives. As the Founder and CEO of SEED Media, Valeisha produces the world's most iconic stories and experiences with the goal to inspire one billion people globally. SEED Media develops best-selling books into commercially viable television and film adaptations. Valeisha also currently serves on the Board of Trustees of her alma mater Clark Atlanta University and Board of Directors for GRAMMY Global Ventures, the global arm of the Recording Academy. She is also the Honorary Chair of the Recording Academy's Black Music

Collective and a Member of the GRAMMYS Television Committee, consecutively producing one of the most diverse and highly rated telecasts on CBS year over year, for the last four seasons. Valeisha previously served as the Co-President of the Recording Academy, Vice President of Global Partnerships and Engagement for Google, Inc., Deputy Director of Public Affairs for International Trade in the Obama Administration and as the National Youth Vote Director for Obama for America, helping to deliver one of the highest youth voter turnouts in American history. A North Carolina native and California resident, Valeisha has been recognized by FORBES, Fortune, Fast Company, ADWEEK, ADCOLOR, EBONY Power100, Billboard, ELLE Magazine's top 25 leading women, ESSENCE and others. Valeisha is also a mom, author, co-founder of the Women in Entertainment Empowerment Network (WEEN) and proud graduate of Clark Atlanta University.

Current Co-Owner of Marysville Toyota in Marysville, Washington, James Colon previously served as Toyota Vice President, African American Business Strategy for North America, where he was responsible for engaging Hispanic and African American business and media communities and building a network of Toyota Associates and team members across regions to optimize relationships with these constituencies. Prior to assuming this role, Colon was vice president of product communications for Toyota Motor Sales (TMS) U.S.A., Inc., where he was responsible for creating, gathering, and managing information for promotion initiatives for Toyota-brand vehicles in addition to product sales and training.

Colon held various roles at Toyota regional offices and TMS headquarters in Torrance, California, including general manager for the Portland and Chicago regions and vice president of sales for the Toyota Division with responsibility for sales support of Toyota regional offices, public companies, and private distributors. **Salvador Diaz-Verson, Jr. (1995)**  
**Sarasota, Florida**

Salvador Diaz-Verson, Jr., is Chairman and President of Diaz-Verson Capital Investments, a company formed in 1993. Previously retired as President and Chief Investment Officer of American Family Life Assurance Company (AFLAC), during which time the Company rose to become a Fortune 500 Company, where among his many achievements was the diversification of the specialty insurance company's operations and holdings, nationally and internationally, opening offices in Japan, Taiwan, Hong Kong, Thailand, Korea, the Cayman Islands, Canada, and the United Kingdom. Mr. Diaz-Verson serves on the Board of Directors of the National Black College Alumni Hall of Fame, Boys & Girls Club of America, Christopher Columbus Fellowship Foundation (GA), St. Francis Hospital (GA), American Cancer Society, United Way, Atlanta Hispanic Chamber of Commerce, Regions Bank and Clemente Capital, Vestmark Inc., Foodsource, LLC, and Diaz Foods, the largest Hispanic-owned company distributing Latino and Specialty Food Products in the nation. Recipient of the Master's degree in Business Administration from Florida State University (FSU), this alumnus was inducted into the University's Hall of Fame in 2005.



**Jeffrey T. Gilbert (2023)**  
**Atlanta, Georgia**

Jeffrey T. Gilbert leads the Global Security & Asset Protection team for The Coca-Cola Company and is responsible for Global (Physical) Security, including Digital Forensics Investigations, Business Threat Intelligence, Associate Safety and Asset Protection, Business Continuity and Resilience, Incident Management and Crisis Resolution (IMCR). He leads a skilled team of security professionals, dedicated to the protection and safety of The Coca-Cola Company brand, associates, and assets. Prior to joining The Coca-Cola Company, Trustee Gilbert served as Sr. Vice President and Chief Security Officer for Warner Media, Inc., where he oversaw global security operations for Warner Media business interests, including HBO, Warner Brothers, Turner Broadcasting, CNN, and CNN International. For over twenty-six years, Mr. Gilbert served with the U.S. Government, including twenty-one years as a Special Agent with the United States Secret Service, where he held several senior executive positions, including the Special Agent in Charge of the United States Secret Service, Atlanta Field Division. Trustee Gilbert currently serves on the Board of Directors of the International Security Foundation (ISF) and the Georgia International Law Enforcement Exchange (GILEE). He maintains professional affiliations with several organizations including the International Security Management Association (ISMA), the U.S. Department of State, Overseas Advisory Council (OSAC), and the National Organization of Black Law Enforcement Executives (NOBLE). ### **Ernest G. Green (1999)** **Washington, D.C.**

Following the 1954 U.S. Supreme Court *Brown vs. Board of Education* decision declaring school segregation illegal, Green and eight other African-American students, later known as the "Little Rock Nine," were the first to integrate Central High School in Little Rock, Arkansas. Several books, movies, and documentaries have chronicled Mr. Green and his eight classmates' experience during their historic year at Central High School. On November 9, 1999, President William Clinton presented the "Little Rock Nine" with the nation's highest civilian honor, the "Congressional Gold Medal." Subsequently, as first member of the "Little Rock Nine" Mr. Green completed high school, earning his diploma from Central High School. Mr. Green is recipient of the Bachelor of Science and Master of Science degrees in Sociology from Michigan State University. He subsequently served as

U.S. Assistant Secretary of Labor for Employment and Training during the administration of President Jimmy Carter and was appointed by President William Clinton as Chairman of the African Development Foundation. On appointment by former United States Secretary of Education, Richard W. Riley, he served as Chairman of the Historically Black Colleges and Universities Capital Financing Advisory Board. In addition to currently serving as member of the Clark Atlanta University Board of Trustees, Mr. Green has also served on the Fisk University Board of Trustees, member of the National Association of Securities professionals (NASP), where he served as Chairman for two consecutive years, Quality Education of Minorities (QEM), Council, United State Conference of Mayors, Action International, and Boy Scouts of America. He is a member of Sigma Pi Phi and Omega Psi Phi Fraternities. The recipient of countless awards during his lifetime, Mr. Green has been awarded honorary doctorate degrees from the University of Arkansas (2012), Spelman College, Central State University, and Tougaloo College. In addition to receiving the Congressional Medal of Honor, Mr. Green witnessed the recent renaming of the street in front of Central High, Little Rock Nine Way, and renaming of a United States submarine in his honor.



### **Keith F. Holmes (2025)**

Keith F. Holmes is a Leadership Coach and former C-Suite executive. At E Leadership Coaching, Keith coaches leaders to develop the skills to influence outcomes and inspire others. Keith founded ELC to use the skills, experiences and abilities gained over 10 successful years to give back, make an impact, and help others achieve their leadership goals. Richard Holmes is retired Senior Vice President of the Metro Atlanta Region for Georgia Power. Prior to appointment as Corporate Compliance Officer in 2004, Mr. Holmes maintained responsibility for electric operations, sales and marketing, customer service/business offices, governmental relations, and community economic development for Georgia Power's 1.2M customers in metropolitan Atlanta. Mr. Holmes previously served on the boards of the Georgia State Department of Community Health (Chairman), Fort McPherson Local Redevelopment Authority, Literacy Action, Kennesaw State University Foundation, Columbus State University Foundation, American Association of Blacks in Energy, Atlanta Branch NAACP, Atlanta Beltline Partnership, and the Atlanta Police Foundation. He is a graduate of Leadership Georgia, Leadership Atlanta, Leadership Cobb, Leadership Columbus, and the Regional Leadership Institute. Mr. Holmes earned his B.S. degree from Columbus State University and the MBA degree from Atlanta University. He also completed the Harvard University Business School Program for Management Development. Mr. Holmes is current chair of the Board of Trustees' Building and Grounds Committee

**Wendy Lewis (2012)**  
**South Orange, New Jersey**

Trustee Lewis is known for her keen ability to build action through intelligence, diplomacy, trust, and consensus-building. As McDonald's former Global Chief Diversity Officer and VP of Community Engagement, she launched the first-ever Global Gender Balance and Diversity Strategy across the enterprise. Her creation of the "Diversity IS Inclusion" mantra became ingrained throughout the business, that resulted in an education framework that targeted the development of culturally intelligent leaders, suppliers, owner-operators, and partners. This led to the design and development of "Food for Thought: Moving Beyond Bias," that brought immediate value and was adopted globally. She was also at the forefront of some of McDonald's most visible programs, including flipping the arches for International Women's Day, strengthening the advancement of McDonald's Employee Business Networks, and partnering across the System to advance supplier diversity and diverse franchising programs.

Also, Wendy Lewis is the founder and creator of AllySHIFT®, a progressive and seismic platform for advocacy and sustainable equity. She is known for shifting the transactional to the transformative and considers herself an evangelist for Life, Liberty and the Pursuit of Equity. Her company, Wendy Lewis, LLC, is a Diversity, Equity & Inclusion practice firm whose focus is empathetic leadership and "allyship sustainability." Prior to McDonald's, the majority of Wendy's career had been with Major League Baseball, where she was the first ever to hold a formal Human Resources Management role within professional sports as the head of HR for the Chicago Cubs. She quickly became known for promoting positive action through a multifaceted approach in gaining awareness, empathy, diplomacy, credibility, trust, and consensus-building, ultimately inspiring and guiding key stakeholders. It was during her early baseball years within the Chicago Cubs franchise where Wendy identified and developed a ground-breaking opportunity to extend the diversity and inclusion practices throughout the immediate organization and into the supply chain, partnerships, and communities. Her executive promotion to the Commissioner's Office for Major League Baseball expanded the scope and scale of her experience and achievements. Her strategic executions resulted in the creation of systems and collaborations that delivered in-depth analysis for the value proposition for the positive ROI. Wendy's integrated insights and deliverables produced MLB's transformational Diversity Economic Impact Engagement, a model for advancing MLB's workforce and supply chain initiatives league-wide. Also, she conceived and developed another first in sports--a centralized strategic planning process for D&I for MLB's 30 franchises, central office, MLB Network, and MLB Advanced Media. She spearheaded many innovative programs and events, such as MLB's Diversity Business Summit, the League's employment and procurement conference. The Summit resulted in new talent pipelines and business partnerships across all MLB entities. **George T. French, Ph.D.**

**Clark Atlanta University**

On September 1, 2019, Dr. George T. French, Jr., became the fifth President of Clark Atlanta University, the largest United Negro College Fund (UNCF) institution in the nation. Prior to his presidential appointment at CAU, Dr. French served for 13 years as the President of Miles College, making him the longest-serving private college president in the State of Alabama, and among the longest-serving and effective private or university presidents in the nation. Under his leadership at Miles College, the institution maintained fiscal stability and growth with a Composite Financial Index among the top 10% of HBCUs in the nation.

According to the United Negro College Fund, Miles ranked as the fourth most financially viable UNCF-college in the nation. Dr. French increased Miles' total operating budget on average of \$2 million per year, and increased the value of endowment assets and total net assets each year significantly. Under his leadership, the College generated \$67 million in total economic impact for its local and regional economies and created 357 on-campus jobs and 730 jobs for its regional economy. During his tenure at Miles, President French secured over \$100 million of funding in support of the College. Additionally, during his tenure, the College nearly tripled the land size of the Campus, while constructing three new buildings simultaneously, renovating every building on Campus, and creating a beautiful atmosphere conducive to learning. A nationally recognized leader and influencer in higher education and educational policy, Dr. French has served three secretaries of education under two presidents as Congressional appointee to the National Advisory Committee on Institutional Quality and Integrity (NACIQI). In this role, he advised the Secretary of Education on the standards of academic accrediting agencies and departmental policy. In addition, the United States Congress appointed Dr. French to serve on the U.S. Department of Education Negotiated Rulemaking Committee in deliberation of access to affordable postsecondary education. Dr. French is a two-term Board of Trustee member for the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). He serves as an officer of the Birmingham Business Alliance Executive Committee as Vice President for Workforce Development. He is also a member of the Regions Bank Diversity Advisory Council, served as Treasurer of the Birmingham Civil Rights Institute, and has won numerous awards, to include Birmingham Spotlight "Man of the Year," NAACP "Man of the Year," and the Higher Education Leadership Foundation Lifetime Achievement Award. 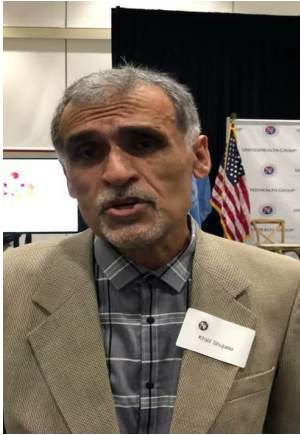

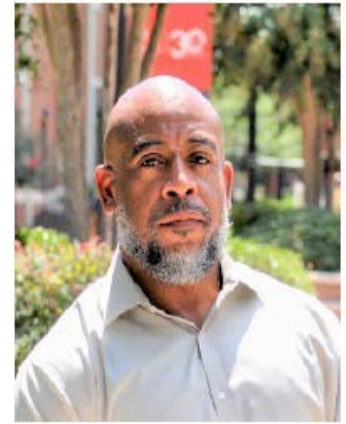
